Title of IFIB: NATO (KFOR) Maintenance Support Contract.

Requirement: The Contractor shall furnish all labour, supervision, tools, materials, equipment, incidental engineering, transportation, quality control, and management necessary for the operation, maintenance, repair, and alteration of facilities and related systems and equipment located at HQ KFOR and sub-sites. The Contractor shall manage the total work effort associated with the operations, maintenance, repair, and all other services required herein to ensure fully adequate and timely completion of these services.

Type of Contract: Firm Fixed Price

Period of Performance: One Base Year and 4 one year options.

Bidding Procedure: Two Sealed Envelopes – lowest technically compliant bidder

Eligibility: Eligible sources are restricted to governmental or commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, which that provide the funding for ACO/ACT HQs and/or specific requirement and (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations. Companies which have performed at least one (1) contract within the last five (5) years substantially similar in scope and magnitude to the requirement described in the solicitation. Only bidders that have been approved by the respective NATO delegations and the appropriate Declaration of Eligibility has been issued will be allowed to participate in this bidding process.


